The Board of Trustees is pleased to announce that effective July 1, 2018, the Iron Workers Local 11 Welfare Fund will cover all In-Network Immunizations at zero cost share for all Active and COBRA Participants and their covered dependents. This coverage is based on the Centers for Disease Control and Prevention (CDC) schedules from infant to older adulthood, which is available on the CDC website by following this link https://www.cdc.gov/vaccines/schedules/index.html.

Statement of Grandfathered Status

The Iron Workers Local 11 Welfare Fund believes this Plan is a "grandfathered health plan" under the Patient Protection and Affordable Care Act (the Affordable Care Act). As permitted by the Affordable Care Act, a grandfathered health plan can preserve certain basic health coverage that was already in effect when that law was enacted. Being a grandfathered health plan means that your Plan may not include certain consumer protections of the Affordable Care Act that apply to other plans, for example, the requirement for the provision of preventive health services without any cost sharing.
